A member terminated in this manner shall not be entitled to a refund of their membership fee. In addition to the above termination rights, the Corporation shall have the right to take appropriate administrative and/or legal action, including criminal prosecution.

No member shall attempt, directly or indirectly, to undermine, disrupt, hinder or interfere with the proper operation of the True Street Drag Racing program in any manner whatsoever.

Membership and its privileges are for lawful purposes only. Any conduct by a Member that, in the Corporation's sole discretion, restricts or inhibits any other Member from using or enjoying the Program will not be permitted. The Corporation shall have the right, but not the obligation, to monitor members' program-related activities, including chat rooms and forums, attendance at races or other events sponsored by the Corporation and other participation in the Program, to determine compliance with these Terms and Conditions. The Corporation's failure to enforce any of these Terms and Conditions shall not constitute a waiver of the rights contained within these Terms and Conditions and/or any rights available to them through the law.

Modification of the Program
